A. Introduction

1. PU Prime is a business name of PU Prime (PTY) Ltd (the "Company", "us", "we", "our", "ours" or "ourselves" as appropriate), an authorised Financial Service Provider ("FSP") registered and regulated by the Financial Sector Conduct Authority ("FSCA") of South Africa under licence number 52218 and located at 37 Harley Street Ferndale, Randburg 2149 Gauteng.
2. The "Million Dollars Cash Pool Terms and Conditions" is an integral part of the "PU Prime Terms and Conditions" and provisions set herein are considered as an annex of all "PU Prime Terms and Conditions" and they should be read in conjunction.

B. Conditions of Eligibility

1. Subject to, and without prejudice to, all other Terms and Conditions, the offer is available to PU Prime's Clients who have satisfied the Eligibility Criteria for the offer ("Eligible Clients") as set out in the sections following hereinafter.
2. The "Million Dollars Cash Pool" may be offered by PU Prime from time to time to clients who open real trading accounts (meaning not demo) with PU Prime, in cases where such clients are referred to PU Prime via specific websites and/or social network sites in the context of certain specific promotions, and/or surveys that PU Prime may be running from time to time on such specific websites and/or social network sites.
3. PU Prime, at its absolute discretion, offers the "Million Dollars Cash Pool" to any Client(s) from any countries/regions, as it deems appropriate and for as long as PU Prime deems to provide it.
4. Only persons who can form legally binding contracts under the laws applicable in their country of residence may participate in the "Million Dollars Cash Pool". Without limiting the foregoing, participation in the "Million Dollars Cash Pool" is not allowed for persons under the age of 18 or otherwise under legal age in their country of residence ("Minors"). If you are a minor, you cannot participate in the "Million Dollars Cash Pool".
5. Participation of "Intermediaries/Related Parties" in the "Million Dollars Cash Pool" is prohibited. If the registration and/or trading data of a participant in the "Million Dollars Cash Pool" corresponds with the registration and/or trading information, including but not limited to IP address, of another participant in the "Million Dollars Cash Pool", PU Prime reserves the right to regard this matching as a reason for immediate disqualification. For the purposes hereof, the term "Intermediary (ies)/Related Party (ies)", when used in these Terms & Conditions, unless the context otherwise requires, shall mean to include any

person or entity bearing a relationship with any participant in the “Million Dollars Cash Pool”, including, without limitation:

- a) family members, such as brothers, sisters, spouses, ancestors, lineal descendants and collateral descendants;
 - b) person or entity, whom any participant in the “Million Dollars Cash Pool”, directly or indirectly through one or more intermediaries, controls, or whom, directly or indirectly, through one or more intermediaries, is controlled by, or is under common control with any participant in the “Million Dollars Cash Pool”; for purposes of this definition, the term “control” (including, with correlative meaning, the terms “controlled by” and “under common control with”), as used with respect to any participant in the “Million Dollars Cash Pool”, shall mean the possession, directly or indirectly through one or more intermediaries, of the power to direct or cause the direction of management policies of such person or entity, whether through ownership of voting securities or otherwise.
6. Similarly, persons associated in any manner whatsoever with PU Prime and/or with the specific websites and/or social network sites on which PU Prime may be running from time-to-time certain specific promotions, contests and/or surveys, in the context of which access to the “Million Dollars Cash Pool” is offered, are not allowed to participate in the offer.

C. Specific “Million Dollars Cash Pool” Terms

1. Promotion areas: All countries covered by regulatory licenses, except for mainland China and/or as per the discretion of the Company.
2. Participation period of this promotion: 2022.12.12 – 2023.01.31
Only the new deposit made during this period will be counted towards the calculation of the cashback.
3. Eligible participants: This offer is available to existing and new clients with PU Prime. (Clients under IBs are allowed to participate. IBs’ own trading accounts are ineligible for the promotion. Clients under Affiliates are allowed to participate. The trading accounts opened by an Affiliate’s own link are not allowed to participate in the promotion. Cent accounts are not allowed to participate. PAMMs and MAMMs need to open an additional account to participate.)
4. The “Million Dollars Cash Pool” is available only for Standard Accounts and Islamic Standard Accounts. *If there are multiple trading accounts under the same client’s name, **only one** eligible trading account is allowed to participate in this promotion.

5. Clients need to fill out the form and successfully activate the Million Dollars Cash Pool promotion on the landing page first, then deposit funds and trading as required to receive the corresponding cashback.

6. Eligible Clients (both new and existing clients) who meet the criteria set forth herein are able to receive cashback, equal to:

7. After making a deposit and receiving the cash voucher, the client has to trade required trading volume **before 2023.01.31**. The cash voucher that the client has received can then be activated and cash voucher amount will directly transfer to their balance.
8. Eligible deposit: Only new deposits made during the promotion period are valid for the promotion. This excludes internal transfers, refer-a-friend bonuses, and cash adjustments. ***If client deposits via cryptocurrency or e-wallet, he will NOT receive the cash voucher.**
9. Once a customer submits a withdrawal during the promotion period, it **will be deemed to have voluntarily withdrawn from the promotion.**
10. Products that count towards the trading requirements: Forex, Gold, Silver, Oil.

11. Effective trading volume: newly opened and closed orders made during the promotion period. Positions open for less than 5 minutes, locked positions, and hedged positions do not count as valid trades for this promotion.
12. This offer cannot be used in conjunction with the following promotions: Refer-A-Friend, 100% Trading Bonus, 20% Exclusive Bonus, and XMAS Make a Wish.
13. PU Prime will not be liable for any costs, expenses or damages which may be suffered as a result of PU Prime re-setting or adjusting a client's account as contemplated by these Terms and Conditions, including, but not limited, to losses attributable to automatically closed out Open Positions.
14. The PU Prime reserves the right, at its sole discretion:
 - i. to decline registration of any participant in the "Million Dollars Cash Pool"; and
 - ii. disqualify any participant in the "Million Dollars Cash Pool" who tampers or breaches these terms and/or any of the "PU Prime Terms and Conditions" set forth on PU Prime's website.
15. PU Prime reserves the right, at its reasonable discretion, to discontinue the offering of this "Million Dollars Cash Pool" to any of its clients, without having to explain the reasons. Such clients will be informed via email.
16. PU Prime reserves the right to alter, amend or terminate the "Million Dollars Cash Pool" or any aspect of it at any time without having to compensate anyone for that. Prior notice of such changes will be given to clients. Please note that taking part in the "Million Dollars Cash Pool" constitutes acceptance and agreement to abide by any such alterations, amendments and/or changes.
17. Any indication or suspicion, in the PU Prime's sole discretion, of any form of arbitrage (including but not limited to risk-free profiting), abuse (including but not limited to participant's trading activity patterns that indicate that the participant solely aims to benefit financially from the cashback without being genuinely interested in trading in the markets and/or taking market risk), fraud, manipulation, cash-back arbitrage connected to a cashback promotion or any other forms of deceitful or fraudulent activity, will nullify all previously cashback of the Eligible Client's real trading accounts with PU Prime and/or any and all transactions carried and/or profits or losses garnered therein. In these circumstances, PU Prime reserves the right, at its sole discretion to close/suspend (either temporarily or permanently) all such Eligible Client's real trading account(s) with PU Prime, cancel all orders and annul all profits of such participant. shall not be liable for any consequences of the cashback cancelation, including, but not limited to, order(s) closure by Stop Out.
